Please note all clubs and delegates must be in good standing, that is defined as all subs must be paid to the District Treasurer into the correct account by the 31st January of the year in question, this includes District, Multiple District and International.

Defined in accordance with the Board Policy manual as follows:
 District (Single, Sub-and Multiple) dues and fees paid in full; and
 No unpaid balance of international dues and fees greater than U.S.\$10, outstanding more than thirty (30) days; and
 No unpaid Lions Club International account balance greater than U.S.\$50, outstanding more than ninety (90) days.

15. Interpretation of the Phrase "Members who have been enrolled for at least one year and a day in the club"

The phrase "members who have been enrolled for at least one year and a day in the club," as the phrase appears in the International Constitution and By-Laws, shall be interpreted to mean the following:

a. A transferee shall be counted as a member for the purpose of calculating the delegate entitlement of the club if the transferee has been a member of receiving transfer club for at least one year and one day.

b. Any member shall be counted as a member of that club for the purpose of calculating the club's delegate entitlement provided that the member has been a full dues paying member of that club for a continuous period of not less than one year and one day.

c. A newly chartered club will be entitled to one delegate and one alternate delegate until it has been chartered for one year and one day. Thereafter, its delegate quota will be based on the number of members enrolled in the club for one year and one day.

d. Clubs being released from status quo will have their delegate quota based on the number of members enrolled in the club for at least one year and one day at the time of being released from status quo. Provided, however, a club being released from status quo will be entitled to a minimum of one delegate and one alternate delegate.

Discounted Member:

A member of this club who pays **discounted dues as a result of their family membership status**, student status or participation in any other discounted membership program offered by the association who desires to retain membership in this club and meets the qualifications for discounted dues. The membership status shall be verified by the board of directors of this club. A Discounted Member shall have all rights of an Active Member but **shall not be included in the club delegate formula calculation.**
